

Child protection scenarios for professionals from different agencies in The Gambia

This document includes a series of case reports on hypothetical patients where child protection is clearly required to address very serious abuse.

After reading each scenario we would like professionals from the agencies that might be involved in child protection, namely social services, the police, the legal profession (magistrates and Judges), doctors and senior nurses involved in examining children in health facilities, and teachers, to complete the forms that follow. The first group of forms addresses what would happen now in 2010 in The Gambia with such a scenario. The second set of forms seeks information from each individual professional on what he/she thinks should happen in an ideal system to help the child and family concerned.

The information in these forms is highly confidential and will not be shared in any way that could identify the individuals completing the forms.

SCENARIO 1 SERIOUS PHYSICAL AND SEXUAL ABUSE

History

Fatima is an 11 year old girl who has fainted during the first class of the day at her school.

Her teacher gives her assistance and finds that blood is running down her legs.

The teacher telephones her mother and then in her own car, takes Fatima to the hospital in Brikama-6 miles away.

On arrival she is seen by the doctor on call. On initial superficial examination she is very pale and shocked with a high heart rate and low blood pressure. This doctor takes blood to prepare for a blood transfusion and gives intravenous fluids to resuscitate her. She is now fully conscious and the doctor notices blood on her legs. He undertakes a full examination after gaining Fatima's consent.

Initial examination

Just before examining Fatima, her mother arrives and comforts her daughter. The examination is undertaken with her mother present.

The shock has now resolved, she is fully conscious and there are no obvious medical illnesses. She is pre-pubertal.

However, there are bruises on her chest that look like adult bite marks. She has multiple fresh and old linear bruises on her back and buttocks. On superficial examination of her genitalia, there are old and new tears to the hymen at 12, 4 and 9 o'clock and an open tear of the perineal body that is actively bleeding. The anus appears normal.

The doctor takes two swabs from the vestibule and places them in a labelled package. He then repairs the bleeding tear under local anaesthetic, using three dissolvable stitches.

Subsequent history

The mother is extremely upset by the obvious injuries and is crying and comforting her daughter. She tells the doctor about her family history.

There are two other children, a boy aged 14 (Ibrahim) and a girl aged 10 (Fatou). Her husband died 5 years ago after peritonitis due to an acute appendicitis that could not be surgically treated because no surgeon was locally available. For the last 2 years the mother, aged 32 years, has been living with a man (aged 36 years) who is the only provider for the family. He works as a taxi driver. There are no other immediate family members who live in the same 2 roomed house in a village of approximately 120 people. The mother's parents are both alive and live in the same village, as does her sister and her family.

At this point, the doctor asks Fatima how these injuries had occurred. She appeared immediately very frightened but then told her mother and the doctor that her step-father had been attacking her for the last few months, threatening her with a knife and gagging her before raping her on several occasions-she cannot remember the exact number. She said that her step-father had attacked her very badly the night before. She had been bleeding all night but was too frightened to say anything as her step-father had threatened to kill her if she told anyone about what was happening.

Subsequent actions

The doctor calls both the local police station and the social services department. The child is transferred from the emergency room and admitted to the children's ward accompanied by her mother.

Before either the police or the social worker arrive on the ward the step-father turns up. He insists on taking the mother and her daughter home. The doctor tries to prevent this and is pushed aside by the step-father. The family leave the ward and are seen getting into the step-father's taxi.

SCENARIO 2 SERIOUS PHYSICAL ABUSE IN AN INFANT

History

Jaka is an 8 month old baby girl who is brought into the hospital emergency room at Brikama by her mother because of shortness of breath.

On arrival she is seen by the doctor on call. On initial superficial examination she is short of breath and shocked with a respiratory rate of 80/minute and a high heart rate of 190 beats per minute. The baby's chest is recessing with each breath.

Initial examination

On full examination, there are bruises around one eye and on the ear of the baby. There is also blood coming from both nostrils and small pin-point haemorrhages around the face and eyes. There is also a very tender ribcage on the left and the right leg is distorted as if there might be an underlying fracture.

The baby is very thin and weighs only 3.8 Kg.

After she has received additional oxygen for about 15 minutes, the baby's breathing improves but is still not normal in rate or pattern.

The baby is fully conscious and there are no obvious medical illnesses, in particular her heart sounds normal. There are some noises in the chest suggestive of possible fluid in the lungs.

Examination of her genitalia is normal.

Subsequent history

The mother tells the doctor about her family history.

Jaka is the mother's first child. The mother is aged 16 years and is unmarried. The father is not involved and does not support the mother or baby.

The mother and baby live in a village in a shed next to the maternal grand-mother's hut. The mother revealed that she finds it very difficult to find food for her and the baby. However, the mother does not appear to be under-weight.

At this point, the doctor asks Jaka's mother how the bruises around the baby's eyes and ears had developed. The mother was unable to explain them.

Then the doctor suggests that X-rays of the baby's chest and leg are required and she both mother and baby will need to go by ambulance to the Royal Victoria Teaching Hospital where this can be done.

The mother becomes angry and states that she is taking her baby home. The doctor pleads with her to remain until the baby's breathing has become safe. The mother refuses, disconnects the oxygen supply and leaves the hospital with her sick baby.

Subsequent actions

The doctor calls both the local police station and the social services department. He informs them that the baby is in great danger and that a probable cause of the baby's difficulty in breathing could be an episode of intentional suffocation.

A social worker also attends the home of the mother and her baby. Again she is refused entry or access to the baby. According to your knowledge and experience of the existing set-up, can you outline below what happens next to address the issues outlined above.
